
The work is to be carried out in consultation with the Executive Engineer, RHD, Road Division, Chittagong and in accordance with the conditions of contract.

Your attention is drawn to the following contract requirements

- 1 The mutual rights and obligations of the Client and the Service Provider shall be as set forth in the Contract, in particular:
 - a. The Service Provider shall carry out the Services in accordance with the provisions of the Contract; and
 - b. The Client shall make payments to the Service Provider in accordance with the provisions of the Contract.
 - c. Contract price is **Tk. 92,88,000.00** (Taka Ninety-Two Lac Eighty-Eight Thousand).
 - d. Contract price can be negotiated during the contract period for any addition / upgradation or subtraction of services.
 - e. The Procuring Entity and the Service Provider may at any time terminate the contract by giving Twenty-Eight (28) days written notice to the other party if any upgradation of Axle Load Control is required. In such event, termination will be without compensation to any party.
- 2 Start Date: You are reminded that start date for the contract shall be the date of issue of the Notice to commence issued by the Engineer to the contractor.
- 3 Program: You are requested to submit the program of work within **15(Fifteen)** days from the date of issue of this letter.
