

Request for Expression of Interest (Eoi) For selection of Consulting Firm (Lump-Sum)

Office of the Executive Engineer, RHD, Road Division, Barisal intends to procure consultancy service from a Consulting Firm (National) towards the cost of Revenue Budget of GOB.

The service include: Consultancy service of Geological & Morphological Study at bridge Site and Feasibility Study For Construction of Mirgonj Bridge over the Arialkha river at 8th K.M. of Rahmatpur-Babugonj-Muladi-Hizla Road (Road No. Z 8034) & Nehalgonj Bridge over the Rangamate river at 9th K.M. of Barisal (Bairagirpool)-Tumchar-Bauphal Road (Z-8910) during the year, 2017-2018.

Brief Description of Assignment: The Government of the Peoples Republic of Bangladesh has decided to Construct the Mirgonj Bridge over the Arialkha river at 8th K.M. of Rahmatpur-Babugonj-Muladi-Hizla Road (Road No. Z 8034) & Nehalgonj Bridge over the Arialkha river at 9th K.M. of Barisal (Bairagirpool)-Tumchar-Bauphal Road (Z-8910)

Expression of Interest (EOI) is invited for Feasibility Study from consulting firms. Main objectives of Feasibility Study of the Bridge Project are to determine economic, financial and technical viability for Mirgonj Bridge over the Arialkha river at 8th K.M. of Rahmatpur-Babugonj-Muladi-Hizla Road (Road No. Z 8034) & Nehalgonj Bridge over the Arialkha river at 9th K.M. of Barisal (Bairagirpool)-Tumchar-Bauphal Road (Z-8910) under Barisal Road Division.

The Study shall include but not limited to the followings: 1) Assess Suitability of smooth alignment of the bridges concerned. 2) Optimization of length, location and alignment of the bridges. 3) Carry out detailed hydraulic, hydrological and morphological study (using fully dynamic one- and two-dimensional mathematical modeling systems) for ascertaining optimum length and location of the bridges as well as river training works, and hydro-morphological impacts of the bridge on the rivers concerned. 4) Assess formation level considering highest flood level. 5) Select suitable bridge type. 6) Location and economic openings from drainage and navigation (As per BIWTC) point of view. 7) Carry out detail Topographic and Bathymetric surveys. 8) Detailed geotechnical investigation at proposed bridge abutment and pier location (soil investigation). 9) Preparation of Land Acquisition Plan (LAP) for bridge and approach road. 10) Detailed Feasibility Study considering economic and financial evaluation determining EIRR, NPV, BCR, and FIRR along with sensitivity analysis for different scenarios.

Reports to be submitted: 1) Hydrological & Morphological study report for both bridges. 2) Feasibility study report for both bridges 3) Sub-soil investigation at bridge abutment and pier location for both bridges. 4) Land acquisition plan for both bridges.

Experience, Resources and Delivery Capacity required: The interested consulting firm must provide information indicating that they are qualified to perform the services. The EOI shall include the following information as a minimum. i) The consulting firm shall have experience as prime consultant for at least 01(one) number similar type of service (feasibility study and hydrological & Morphological Study) during the last ten years. (ii) Background of the firm with general and overall experience including company's brochure. (iii) Firm's name should indicate the form of association (joint venture or sub-consultancy). In case of a joint venture the name of the partner in charge and address must be mentioned in the document. A copy of registration certificate with relevant professional body (ies) with proof of latest/updated renewal. (iv) General information including legal documents i.e company registration/Trade license, TIN and VAT registration certificate, Income tax certificate etc. (v) List of similar nature of services completed and in progress. (vi) Relevant experienced and professional qualified personnel and staffs.(vii) Availability of resources to carry out the assignment.(viii) Administrative strength, logistics and financial capability.(ix) The financial capability should be shown as financial turnover supported by payment certificate (public fund) for the last Five years.


The EOI would be reviewed on the basis of the following: a) Registration of firm b) Availability of key professionals with CVs c) Turnover of the consulting firm d) Experience of the firm(s) in similar tasks e) History of litigation (if any) in courts or any arbitrations proceedings f) List of award winning project by consultancy firm.

A Consultant will be selected using the Least Cost Selection (LCS) procurement method in accordance with the public procurement Rules 2008 issued by the GoB. Interested applicants may obtain further information by applying to the address below during normal office hours.

Submission of Eoi should be done in closed envelop bearing the name and address of the applicant, Eoi no. and date and addressing to the Eoi issuing Authority in 2(two) copies, 01(one) marked as "ORIGINAL" and the other as "COPY".
