1. BACKGROUND

The Sylhet-Charkhai-Sheola Highway Road segment is an important part of Bangladesh-China, India, and Myanmar (BCIM) corridor and South Asia Sub Regional Economic Corridor (SASEC) 5. The BCIM corridor will cover encompassing an estimated 440 million people in China's Yunnan province, Bangladesh, Myanmar, and Seven Sisters in North-Eastern India through the combination of road, rail, water, and air linkages in the region. The BCIM envisages greater market access for goods, services and energy, elimination of non-tariff barriers, better trade facilitation, investment in infrastructure development, and joint exploration and development of mineral, water, and other natural resources. The upgradation of Sylhet-Charkhai-Sheola Highway Road, one of the subprojects under Component 4: Regional Connectivity Infrastructure of BBIN (Bangladesh-Bhutan-India-Nepal) cargo route. These international economic corridors provide international traffic to several land ports and seaports. Also, through these corridors, there will be cross-border movement of goods and passengers. Development of this road will enhance facilitation of faster and safer movements of passenger and cargo. On June 28, 2022, Sylhet-Charkhai-Sheola Highway Improvement Project was approved by the World Bank's (WB) Board of Executive Directors. Also, an aid-memoire has been signed between Economic Relation Division (ERD) and WB on October 18, 2022. The Roads and Highways Department (RHD) under the Ministry of Road Transport and Bridges (MoRTB) will be the implementing agency for this Investment Project. The Project was approved by GOB in ECNEC meeting on 11 April 2023.

The scope of civil works under the Investment Project includes the Improvement of the existing 2-Lane Road over the length of approximately 42.985 km into a 4-Lane divided carriageway with 5.5 m width Service Lanes on both sides. As a part of regional connectivity Sylhet-Charkhai-Shoela Highway (42.985 km) will be developed with 1 Flyover, 03 Bridges, 31 Culverts, 06 Overpasses, 02 Pedestrian Underpasses, 04 Pedestrian Foot Over Bridges, 07 Pedestrian crossings, 10 Bus Bay (Both sides), Crossings, 1 no. Toll Plaza and the like.

The project will be managed by a Project Implementation Unit (PIU) comprised of 14 nos. officials mentioned in **Table 1.** The Project Director (PD) will lead the PIU and also act as a client for all procurement. Moreover, the Chief Engineer of RHD will act as Head of Procuring Entity (HOPE).

2. OBJECTIVE OF THE ASSIGNMENT

The objective of the assignment is to: (i) provide expertise support in all procurement process starting from bidding document preparation to award the contract and (ii) closely monitor the contract management process of the signed contracts of RHD PIU on behalf of PD for proper implementation of the project.

3. SCOPE OF SERVICES

The Procurement Consultant (PC) will work as a full-time member of the procurement team in PIU and will be responsible for assisting RHD so that the procurements are done as per the relevant Regulations of WB. The PC will have a significant role in assuring the integrity, fairness, and overall quality of procurement in conformance with the requirements of the guidelines of the WB and the procurement laws of Bangladesh. He should not have any conflict of interest while working and should keep all the project information confidential. The PC will carry out the following main activities:

- Develop procurement plan for IT-Goods, Goods, Works, and Services under the project, and update the Plan as and when needed (at least quarterly) through the Bank's Systematic Tracking of Procurement Exchanges system (STEP). Upload and update the procurement transactions using STEP.
- Prepare drafts to Request for Expressions of Interest (REOI), Invitation for Bids (IFB), Invitation for Prequalification (IFP), Bidding Document, Request for Proposals (RFP), Pre-Bid Meeting Minutes, and assist in Bid evaluation as per WB Procurement Regulations;

- Prepare quarterly report on procurement status and procurement risk mitigation framework and arrange submission of the same to IDA for review.
- Assist in preparing TORs and associated documents for other consultants, as appropriate.
- Conduct diagnostic analyses on delays, inefficiency, etc. in the system, and provide recommendations to improve the same, if required.
- Conduct site visits and verify supervision consultant's (if any) periodic reports on physical progress.
- Prepare contract management checklist and suggest improvement of contract administration by different contractors at different sites.
- Conduct procurement activities under the project using CPTU's e-GP portal as applicable.
- Transfer of knowledge by the consultant to Ministry officials who will be specifically assigned by PIU as the trainees and expected to take over procurement tasks for the project by the end of the Consultant's contract after 2 years (expiration of consultant's contract).
- Any other task assigned by the PD/project management as and when required.

- Quarterly Monitoring reports of deliverables of works, goods, and consulting services contracts (progress, quality, completion etc.)
- Procurement documentation and records are systematically maintained so as to be readily available for review and audit.

7. INSTITUITIONAL ARRANGEMENT/ COUNTER PART SUPPORT

The PC will work under the direct control of the PD. He/she will report directly to the PD in close collaboration with other officials of the Project. The PC will be accountable to the PD for his/her day-to-day activities. The project will provide working space and necessary logistical support for the PC at PIU premises in Dhaka.

8. SELECTION METHOD

Selection of the PC will follow the procedures for selecting Individual Consultants described in the WB's Procurement Regulation for IPF Borrowers (July 2016, Revised November 2017, August 2018 and November 2020).

9. DURATION

The duration of the assignment will be period of Twenty (20) man-months, depending on the need of the client and satisfactory performance of the consultant. At least Twenty-Two (22) business days of service will be considered a month and eight (8) working hours a day. The Contract period may be extended on mutually agreed terms if required as per rules and regulation of WB and GOB.
